I, the undersigned, would like to join the Spinal Conservative Care Physiotherapist Network, which is subject to the following terms and conditions:

1. I agree that I meet the network eligibility criteria as set out in the cover letter. Please provide copies of all relevant registrations and documents as required.
2. Claims will be reimbursed as per the Spinal Conservative Care Programme episode fee, as defined in the cover letter.
3. The applicable payments will be triggered at specific points in the programme, following data capture on HealthID.
4. The practice agrees to bill members at the applicable programme episode fee for the duration of the spinal programme, without any form of balance billing, for example levies, admin fees or claim any spinal-related fee-for-service treatment codes during the duration of the programme.
5. The practice will submit the required clinical information on HealthID at the three specified points during the Spinal Conservative Care Programme.
6. I agree to participate in the Discovery Health peer review/mentoring processes involving the exchange of clinical / administrative data and information towards jointly promoting an efficient and high-quality healthcare system.
7. Discovery Health will only consider claims for service dates later than the date of receipt of the signed agreement and activation of the practice on the Spinal Conservative Care Network and after successful enrolment of eligible members on the programme.
8. The Spinal Conservative Care Programme episode fee will also apply to participating, closed medical schemes administered by Discovery Health, up to the applicable programme rate and subject to the benefits offered by that scheme. The current list is included in Annexure A in

the cover letter.

9. New schemes coming under the administration of Discovery Health, who would like to be included in this agreement, will be automatically included subject to approval of the scheme's board of trustees. Any changes to this list will be published on our website at www.discovery.co.za.
10. The Spinal Conservative Care Programme does not apply to members on Keycare plans or the Essential Smart Plan.
11. This agreement may be terminated with **30 (thirty) days** written notice by either party, except in the case of demonstrated fraudulent activity, which would result in immediate termination.
